Do not exceed 1500 characters (approximately 230 to 245 words) for the total of your abstract title and body, including section titles and tables.

The character count excludes institutions, author names, and spaces. One data table per abstract is permitted. Figures and illustrations are not allowed.

Submission of an abstract implies the author(s)' agreement to publish the abstract in the conference program and on the Energia Middle East Website

If you are submitting more than one abstract, a separate submission must be made for each one. The Program Committee will be responsible for evaluating abstracts.

Every effort will be made to accommodate the author(s) presentation preference. However, the Program Committee reserves the right to rearrange the presentation to best suit the program length. Presenters must register and pay for travel and accommodation expenses.
